Subject: Transportation Survey Results, Fall 2024

Overview:

The purpose of the transportation survey was to glean how students travel to De Anza, and for those students who plan to take classes at Foothill College, how they would travel to that campus. The survey was administered online to students who were enrolled in the fall 2024 quarter. A total of 1,072 responses were collected between December 4 and 16, 2024. The results are disaggregated by two self-reported groups, resident (CA or another U.S. state) and international (F1 visa).

Summary:

- Survey respondents consisted of Resident (73%), F1 Visa (10%) and unknown (17%).
- San Jose and Cupertino were the primary residential cities cited. A higher proportion of Resident respondents reside in San Jose, whereas Cupertino was home to a larger proportion of F1 Visa respondents.
- Most of the respondents in the Resident and F1 Visa groups enrolled in both in-person and online classes at De Anza, followed by in-person and online classes.
- Overall, respondents were likely to drive a personal vehicle to get to their in-person classes at De Anza, followed by public transit. Very few used carpool or ride-share.
- Accounting for selected and written-in responses, F1 Visa respondents were more likely to rely on a non-personal means of transportation to De Anza, whether it be public transit, carpool and/or ride-share, than compared to Resident respondents, 70% versus 35%.

- The majority of respondents <u>do not plan to enroll in any in-person classes at Foothill</u> next winter 2025 quarter (72%). The results were consistent across the Resident (82%) and F1 Visa (78%) respondent groups.
- If a low-cost ride service was available from De Anza to Foothill, most Resident and F1 Visa respondent groups would use the service; however, interest for the service dipped if the

service was only available one-way from De Anza to Foothill. This finding was consistent among Resident and F1 Visa respondents whether they plan to or do not plan to take an inperson class at Foothill in the winter 2025 quarter.

A. Respondent Overview

A1. Residency Status (self-reported)

- 73% (N=786) identified as residents of California or another U.S. state
- 10% (N=102) identified as F1 Visa students of De Anza
- 17% (N=184) chose not to specify their status

A2. City of Residence

• While Cupertino and San Jose were the top two residential cities for both respondent groups, Cupertino was home to a larger proportion of F1 Visa (39%) than Resident (12%) respondents.

A3. Instructional Modality at De Anza

• The majority of respondents enrolled in both in-person and online classes at De Anza (63%), followed by in-person classes only (26%). The results were consistent across the Resident and F1 Visa respondent groups.

A4. Mode of Transportation to De Anza

Among those who took some in-person classes at De Anza (N=949), they were probed on their mode of transportation to the campus for the in-person portion of their class.

- Even when "other" responses were examined and accounted for, overall, most respondents drove a motor vehicle, followed by public transit. Very few respondents reported they carpooled or used some ride-share (e.g., Uber, Lyft or Silicon Valley Hopper).
- F1 Visa respondents were more likely to rely on public transportation than Resident respondents, 54% versus 25%, as well as carpool and/or ride-share.

B. Interest in In-Person Class at Foothill College, Winter 2025

• The majority of respondents do not plan to enroll in any in-person classes at Foothill next winter 2025 quarter (72%). The results were consistent across the Resident (82%) and F1 Visa (78%) respondent groups.

B1. Yes, Plan to Take In-Personal Class at Foothill College

Respondents who indicated they will or might enroll in an in-person class at Foothill next winter 2025 quarter (N=286) received additional survey questions. Of the 286 respondents, 107 chose not to respond to the follow-up questions. Below are the results for the 179 respondents who did.

- Rationale (Table 5): Plans to enroll in face-to-face classes at Foothill was primarily due to interest in a program at Foothill or a desired class was full at De Anza. The results were consistent across the Resident and F1 Visa respondent groups.
- Frequency (Table 6): Both respondent groups anticipate they will travel to Foothill up to two times per week, 72% of Resident and 73% of F1 Visa respondents.
- Mode of transportation (Table 7): Resident respondents plan to take a personal mode of transportation to Foothill campus (i.e., vehicle, bike, motorcycle), followed by public transit. Most F1 Visa respondents plan to rely on public transportation. Additionally, a higher proportion of F1 Visa respondents plan to use ride-share or carpool compared to Resident respondents, 23% versus 6%.
- Starting destination (Tables 8A and 8B): Most Resident respondents plan to commute from their home or job to Foothill, whereas F1 Visa respondents plan to commute from De Anza to Foothill. The majority of Resident and F1 Visa respondents who plan to commute from their home or job to Foothill said their home/job is not in Cupertino, 84% and 56%.

• Interest in using low-cost ride service from De Anza to Foothill (Tables 9A-9C):

Respondents who met either of these two conditions were asked if they would use a low-cost ride service from De Anza to Foothill: (1) commute directly from De Anza to Foothill or (2) commute from home/job which is in Cupertino to Foothill. The following findings were consistent across the Resident and F1 Visa respondent groups. There was a total of 79 respondents.

- Over 60% would use the low-cost ride service. Another 25% might use the service.
- Among those who would or might use the ride service, 51% would use the service two or three times a week. Another 26% would use it one time per week.
- If the ride service was only available one-way from De Anza to Foothill, most respondents would or might still use the service, Resident (57%) and F1 Visa (76%).

B2. No, Do Not Plan to Take In-Personal Class at Foothill College

Among respondents who do not plan to enroll in an in-person class at Foothill next winter 2025 quarter (N=769), they were asked if having access to a low-cost ride service from De Anza to Foothill would make them more likely to consider taking classes at Foothill.

- Reconsider taking classes at Foothill if low-cost ride service was available (Table 10A): A little over 50% would or might consider taking classes at Foothill if a low-cost ride service was available from De Anza to Foothill campus. F1 Visa respondents were more likely to reconsider taking a Foothill class than Resident respondents, 67% versus 51%.
- Use low-cost ride service if it was one-way from De Anza to Foothill (Table 10B): If the low-cost ride service was only available one-way from De Anza to Foothill, very few respondents (33%) would or might use the ride service. The results were consistent across the Resident (35%) and F1 Visa (28%) respondent groups.
